At this meeting, the Governing Board (Board) will have the opportunity to approve the Data and Tools and Community Engagement Advisory Board candidates that were slated by the Selection Ad Hoc Committee (Committee).

Requested Action:

After review and consideration of the slating of candidates for the Data and Tools and Community Engagement Advisory Boards, Staff recommends that the Board approve the slated candidates as presented by the Committee.

- Move to approve the proposed candidates and runners up for the Data and Tools Advisory Board as specified in the staff report.
- Move to approve the proposed candidates and runners up for the Community Engagement Advisory Board as specified in the staff report.

Data and Tools Background:

As the <u>Governance Manual</u> states the Committee met in April in advance of the recruitment process to provide input on the application materials and the dissemination plan. When the applications closed, the Committee reviewed and scored each application against the rubric, with multiple Committee members reading each application. Once all members completed scoring, Office of Cradle-to-Career Data (Office) aggregated assessments. The Committee met again in June to discuss potential slates for each Advisory Board at a public meeting and rank-ordered runner up candidates.

Data and Tools Selection Process:

In total, the Committee reviewed and received <u>63 applications</u> for five impending vacancies. The Committee also received the <u>scoring rubric</u> which defines the criteria used for scoring the applications, <u>letters of support</u> received by the Office for candidates, a summary spreadsheet with the applicants assigned to each member for review, and a Google form to submit the results of scoring the applicants.

Selection of Seats by Category:

To facilitate the Committee's decision making, the Office organized the applications by category relative to the sector or population represented. Based on the applications received and the Governing Manual's guidance to aim for diverse perspectives and backgrounds, Staff recommended to the Committee the following number of seats per category.
