Welcome

Written Comment submitted by the California EDGE Coalition:

Dear Members of the Cradle-to-Career Governing Board:

As organizations representing sectors in education, workforce, labor, business, and social justice, we write to respectfully urge your support for the appointment of Anna Alvarado to serve as a member of the Community Engagement Advisory Board.

As you know, the Community Engagement Advisory Board will create strong feedback loops with data users to support evidence-based decision making, analytical capacity, equitable access, and promote diversity and inclusivity in building engagement with the data system. Last year, Ms. Alvarado served as a member of the Cradle-to-Career Community Engagement Subcommittee, where she provided input and feedback on key outreach strategies, such as helping develop a clear understanding of target audiences; provided input on a communications plan that will raise awareness of the system - why it matters and how to use it. Additionally, Ms. Alvarado provided recommendations to ensure community-based organizations are part of the outreach plan, ensure all communications to users are accessible and available in various languages, and provided input on strategies related to the use of social media and other outreach activities to better engage and inform the public.

Savannah, from The Campaign for College Opportunity, expressed support for the following candidates: Marshall Anthony, Jr., Ph.D., The Institute of College Access and Success (TICAS); Vikash Reddy, Ph.D., The Campaign for College

Jackie Nevarez, practitioner in the K-12 space in Sacramento, thanked the Governing Board for her nomination and shared her qualifications for the role.

Mary Munez, Executive Director of College Promise Coalition, supported the proposed slate of members of the Community Engagement Advisory Board, including Ms. Viveros-Walton.

Executive Director's Remarks

Mary Ann Bates, the Executive Director of C2C, presented an update on C2C. She explained that sixteen entities signed legal agreements that allow data to be combined to create the analytical data set. Ms. Bates also shared an

update that the Request for Proposals for the tools necessary to build the analytical data set have been released (see:

https://caleprocure.ca.gov/event/0511/0000023405), and advised the Governing Board and staff to be mindful of communications regarding the solicitation until the vendor has been selected. Then, Ron Marryott, attorney for C2C, explained that the solicitation process will occur over the next five or six weeks. Mr. Marryott advised Board Members to contact Sydney Armendariz if they receive a question from the public or industry about the solicitation.

Next, Ms. Bates shared a hiring update. C2C has posted three senior positions: Director of Data Programs, Director of Data Systems, and Director of Engagement. https://c2c.ca.gov/careers/

Ms. Bates gave an update on the California College Guidance Initiative. Through C2C, school districts can now access CCGI's tools for free, which has resulted in many districts seeking to access the platform. By fall 2022, an additional 200,000 students will have access to financial aid, college, and career planning tools and streamlined financial aid and college applications.

Ms. Bates shared information about the launch of monthly community conversations, with the first one on June 8, 2022.

Governance Manual Edits

Board Member, Gavin Payne, presented edits to the Governance Manual proposed by an ad hoc committee of board members. Changes included:

- Agreements Page: lists timing for editing manual, references other documents that create policies
- Preface: specifies the data system purpose, implements a consistent naming convention for the Office of Cradle-to-Career Data
- Governance: revises the image regarding communications and scopes of responsibility for the Office, advisory boards, ad hoc committees, and taskforces

- Roles and Responsibilities Chart:
- Board: adds Executive Director evaluation
- Data & Tools Advisory Board: adds emphasis on continuous improvement for reviewing research requests
- Office: adds support for data request process review, emphasizes data security, adds support for coordination among data providers
- Data Providers: clarify required approval for data usage
- Meetings: describes the scheduling process, attendance expectations, threshold for quorum
- Decision-making: clarifies how alternates are appointed
- Board Chair: describes the responsibilities of the Board Chair Elect and the Standing Chair, outlines the process for running for Board Chair
- Ad Hoc Committees: describes how ad hoc committees are created
- Communications: outlines Governing Board and Office responsibilities
- Managing Entity: emphasizes data security, clarifies lead role in setting security policies, describes how taskforces are created
- Appendix: provides a link rather than text of Bagley-Keene Act

The Governing Board voted on the following motion: Adopt the edits made by the Governance Manual Ad Hoc Committee to the Cradle-to-Career Governance Manual.

Mr. Payne moved to approve the Governance Manual. Ms. Aviña seconded the motion.

The motion passed unanimously with 20 "yes" votes with one Board Member absent.

Incoming Board Chair Election

Board Chair Amy Fong explained the process for electing a new Board Chair. The incoming Board Chair will begin their term on July 1, 2022. The Board received one letter of interest from Robert Tagorda.

Gavin Payne moved to elect Robert Tagorda as the next C2C Governing Board Chair. Sylvia Alva seconded the motion. The motion passed unanimously, with one Board Member abstaining (Robert Tagorda), and one Board Member absent (Lande Ajose).

Advisory Board Appointments

Kathy Booth from WestEd provided background information about the Data & Tools Advisory Board and Community Engagement Advisory Board. Mary Ann Bates, Executive Director of C2C, and John Hetts, California Community Colleges, detailed the process of selecting Advisory Board members.

John Hetts explained an issue that arose during the deliberations of whether candidates from organizations represented on the Governing Board can serve on these Advisory Boards. The Ad Hoc Committee recommended that the two candidates, Jacob Jackson from Public Policy Institute of California and Liberty Van Natten from the California Department of Education, who are members of organizations represented on the Governing Board, serve a one-year term.

The board held an extensive discussion about how to identify the types of people that should be prioritized for service on the advisory boards each year. These issues will be addressed by the Governance Manual Ad Hoc Committee in its next round of revisions.

Wesley Whitaker, alternate for Assemblymember Jacqui Irwin, moved to adopt the 16 finalists and 12 named runners-up to the Data & Tools Advisory Board, pending the finalists' acceptance. Thomas Vu, Association of Independent California Colleges and Universities, seconded the motion. The motion passed unanimously. Seven Governing Board members voted "Yes, with reservations", and one Board Member was absent (Lande Ajose).

 "Yes, with reservations" Explanations (the following are paraphrased summaries and not direct quotes)

- Sylvia Alva, California State University: C2C does not have a system yet, and is putting things out of order. C2C could benefit from holding off until we have thought through the questions. There is no urgency to vote on this slate.
- Marisol Aviña, California Endowment: There are concerns about the Advisory Board candidates in organizations represented on the Governing Board. There is limited representation of students and families.
- Catalina Cifuentes, Riverside County Office of Education:
 Understanding what we're going to do in year 1 and year 2; who's missing from this group, especially regarding early outcomes.

 Having students at the table at the beginning is important.
- Ohris Furgiuele, University of California Office of the President: There are concerns that expertise is not adequately represented and bringing in outside expertise could raise inconsistencies and accountability issues. We need expertise to build the system first, and it's not clear that it's represented in this slate.
- John Hetts, California Community Colleges: Having people in the organization gives an opportunity to rely on and draw from their expertise.
- Wesley Whitaker, alternate for Assemblymember Jacqui Irwin: We should make sure students and families are at the table when making decisions. There is good representation on this slate and will see the formalization about how technical expertise will be brought forward.
- Meredith Lee, University of California, Berkeley: Rather than tagging a specific candidate as community organization versus practitioner, some of the candidates represent value from multiple buckets.

Gavin Payne moved to adopt the 16 finalists and 6 named runners-up to the Community Engagement Advisory Board, pending the finalists' acceptance. David DeGuire, Commission on Teacher Credentialing, seconded the motion.

The motion passed unanimously. One Governing Board member voted "Yes, with reservations", and one Board Member absent (Lande Ajose).

- "Yes, with reservations" Explanations (the following is a paraphrased summaries and not a direct quote)
 - Marisol Aviña, California Endowment: There is no student or family representation in the candidate slate.

John Hetts, California Community Colleges, moved to adopt the motion, "If an individual declines to be seated or has a conflict of interest, the next runner up will be approached, in the order recommended by the Ad Hoc Committee." Sean Elo-Rivera, San Diego City Council, seconded the motion. The motion passed unanimously with one Board Member absent (Lande Ajose).

New Ad Hoc Committees and Task Forces

Amy Fong, Board Chair, explained the differences between ad hoc committees and task forces. The Governing Board convenes ad hoc committees, which are subject to the Bagley-Keene Open Meeting Act, in-person in Sacramento, and the meetings must comply with process and timeline requirements. The C2C office convenes task forces, which are not subject to the Bagley-Keene Open Meeting Act (as long as two or fewer board members are part of the task force), are open to the public, and typically will meet virtually.

Mary Ann Bates, Executive Director of C2C, described the upcoming task forces:

- Security Policy Task Force: security experts from the data providers
- Employment Data and Teacher Data Task Force: data experts from the data providers, researchers, and data experts

Chris Furgiuele, University of California, Office of the President, recommended a long-term Security Policy task force to underscore the importance of risk management.

Adjournment

Amy Fong, Board Chair, adjourned the meeting.
