Re: Recommendation for Alexis Takagi – California Cradle to Career Community Data System – Community Engagement Advisory Board

To Whom it May Concern:

I am enthusiastic to recommend Alexis Takagi as a representative on the statewide Cradle to Career (C2C) Community Engagement Advisory Board. I have known Alexis for almost two years, first as a student advocate and now as a colleague in our roles representing the independent California colleges and universities (ICCU) sector.

I began mentoring Alexis through her involvement with AICCU's Independent California Colleges Advocate Program (ICCAP), a six-month student advocacy program that I manage. Alexis served as co-chair of the Policy and Budget Advocacy Team, a leadership role she handled very well. Her collaborative efforts with her peers resulted in a remarkable achievement: securing a \$25.9 million investment in the Cal Grant Program for students attending ICCUs, in the 2022 state budget. Alexis spearheaded the development of the cohort's policy priorities, focusing on key areas such as enhancing affordability, bolstering student support and services both on and off campus, and advocating for post-secondary opportunities for undocumented students. Her leadership and authorship played a pivotal role in advancing these important initiatives impacting over 27,000 ICCU students.

As a recent graduate of Santa Clara University (SCU) and a current Doctor of Education (EdD) candidate in the Social Justice Leadership program at SCU, Alexis can tap into her recent experience as a transfer student, navigating various higher educational sectors as well as her mentorship experience helping other students navigate similar experiences. Alexis remains deeply engaged in her communities, constantly attuned to local, regional, and statewide diverse needs. I have witnessed her growth from student advocate, graduate student/researcher to now an Outreach Coordinator at Stanford University. I am proud of how Alexis has utilized the ICCAP experience and actively applies the principles she is gaining in her Ed.D program at SCU in real time. This advanced degree has helped her sharpen her research skills, utilize data to support college planning among other equity initiatives in her various leadership roles.

For example, Alexis plays a pivotal role in coordinating numerous partnerships with local community colleges. Through these collaborations, Alexis has facilitated opportunities for students to participate in STEM workshops, providing them with exposure to college

experiences. By leveraging her expertise and combining it with her passion for equitable education, Alexis has made significant contributions to empowering students and fostering inclusivity in educational settings. This direct contact and experience with student initiatives would add value to the C2C Community Engagement Advisory Board.

Alexis, leverages her knowledge gained from her EdD, has successfully applied her expertise to enhance her support for students and families. She currently holds the position of a research assistant, where she dedicates her efforts to studying college choice and postsecondary readiness. Simultaneously, Alexis serves as a graduate assistant within Santa Clara University's Thriving Neighbors Program. This program focuses on fostering success at every stage of the K-12 educational pipeline, specifically targeting first-generation students of color and preparing them for college. Her extensive experience working directly with students and families has enabled her to foster research-practitioner partnerships, facilitate collaboration and data collection stewardship to better address local, regional, and statewide unique needs.

In closing, Alexis has an unwavering commitment to advocating for college affordability, and accessibility, so that all students regardless of their background can achieve their educational goals. Her skills and experience would bring a unique approach to the work of the Cradle to Career Community Engagement Advisory Board that would contribute to the advancement of the board's mission, particularly in her advisory role on framing C2C data to empower decision makers to support students' success.

To Whom It May Concern:

It is my pleasure to recommend Alexis R. Takagi to serve on the Cradle to Career Community and Outreach Advisory Board. Alexis is currently a doctoral student at Santa Clara University's (SCU) Social Justice Leadership program. SCU's doctor of education (EdD) program is designed to prepare students to participate in and lead complex organizations working to transform educational opportunities and outcomes for traditionally marginalized communities. As part of this process, we ground our work in the Jesuit tradition of "cura personalis" – care for the whole person. Alexis exhibits these qualities in multiple ways.

As an emerging scholar, Alexis's research focuses on the educational experiences of community college students. She is committed to centering their stories and to identify ways for institutions to serve them in humanizing ways. To do so, Alexis draws on her personal experiences across the community college system, offering a keen understanding on how to improve counseling services and mentoring opportunities. Her knowledge in this area is also helping to advance educational scholarship. Presently, we are co-writing a manuscript on Latinx students' decision-making process in attending community college. I invited her to participate in this project because I have been impressed with her analytic skills and thoughtfulness in discussing student narratives. Alexis has been pivotal in synthesizing relevant literature and analyze data in ways that highlight system supports and barriers. Given her knowledge of the community college system, I have relied on her unique insights to confirm interpretations of the data. Her involvement has also helped ground the work in ways that support decision-making through data-use.

I have also been impressed with Alexis's support and advocacy for undocumented students. As the California Student Aid Commission's (CSAC) student representative she participated in a working group that produced a report on the challenges undocumented student encounter while navigating higher education in California. This work is important, but also difficult as it requires the ability to navigate a variety of issues (e.g., immigration status, economic disparities, immigration enforcement, academic opportunities, etc.) that involves experts across different disciplines. Alexis's ability to build relationships with different stakeholders has made her an important contributor to this work. Given these experiences, I have no doubt that Alexis will provide an important point of view to the advisory board. My name is Mike Nguyen, and I wear many different hats in my life - Youth Commissioner of Santa Clara County, Student Member of the County Registrar of Voters, National Advisor to The Kroger Company, and Speaker at Second Harvest of Silicon Valley. I have consistently been a fierce advocate, from educating organizations like Apple to Stanford University Biodesign and bringing youth rights to the forefront of my mission.

Above all this, I am a student and learner, a product of my local Title 1 public schools, a product of De Anza Community College as a dual enrollment student, and an incoming undergraduate at the University of California, Berkeley. This year, I witnessed the college admissions process firsthand, navigating the UC, CSU, and Common Applications, as well as the FAFSA, CSS Profile, and Naviance. At its heart, C2C's analytics will ensure that students no longer need to dream of who they hope to become. They can interpret this critical data to receive the proper guidance to make their dreams a reality.

My public service has led me up to this moment in time, where I have the chance to make real change happen and provide meaningful insights as a Student Representative for the C2C Community Engagement Advisory Board. Our community matters and education is at stake, but I am confident we can work together to lead students on a pathway to a brighter future.
