Subject: Selection for Advisory Board Members Process Update

At this meeting, the Governing Board (Board) will have the opportunity to receive an overview of the selection process for new Advisory Board members and hear updates from the Selection for Advisory Boards Committee (Committee).

Requested Action:

There is no requested action for this item. This is an informational item only.

Background:

At the February 28, 2024 Board meeting, the Committee <u>charter</u> was approved, and five Board members were designated to form the Committee. Their role is to finalize selection and recruitment materials and to identify a candidate pool for Board approval. Member Payne is the Chair of this Committee and Board members Gonzalez-Vasquez, Romero, Ohanian, Vu serve on this Committee.

April 12, 2024 Committee Meeting:

As the Data and Tools Advisory Board and Community Engagement Advisory Board face vacancies, the Committee met on April 12 to approve and provide input on the application, rubric, and selection process plan. In addition, the Committee deliberated on the ideal populations for appointment and prioritization of future candidate categories for Advisory Boards. The 2024 Advisory boards application forms will be posted on the C2C website from April 29, 2024 through May 17, 2024 for interested candidates to apply.

To streamline the application process for the public, the Office of Cradle-to-Career Data (Office) has developed a page on the C2C website to house all application resources and information. It serves as a static landing page that the Office will update every Spring with the new application for the Advisory Board. This year, the application will be featured in Spanish and English. The page will also highlight key information, such as when the application will open and close.

In an effort to seat diverse Advisory Boards, the Office drafted a comprehensive and strategic outreach plan that was presented to the Committee. The Office will look to Board members to assist in the recruitment of Advisory Board members. The Office would like to work with members to ensure the information is shared with a diverse and inclusive audience, reflecting the breadth of perspectives and experiences within the State.

Selection Process for New Advisory Board Members:

The following members of the Data and Tools Advisory Board will cycle off in August: Marshall Anthony Jr., Lisa Chavez, Khathy Hoang, Brendan Livingston, and Jennifer Orlick, leaving five vacancies on the Data and Tools Advisory Board. The following members of the Community Engagement Advisory Board will cycle off in August: Meredith Curry Nuñez, Nancy Jodaitis, Paige Loverin, and Marcos Montes, leaving four vacancies on the Community Engagement Advisory Board. Information regarding the breakdown of term limits and representation can be found in Attachment A. The term for the new positions will be from 2024 through 2027. The Committee will reconvene in June to determine slating, which the Board will have final approval of at the August 2024 Board meeting.
