<b>Milestone</b>	Data and Tools 2024 proposal form will be live on the <a href="#">C2C website</a> , enabling members of the public to submit their ideas. <u>Deadline: Tuesday, March 19, 2024</u>
<b>Summer</b>	
<b>Milestone</b>	2024 proposal forms are due from the public. <u>Deadline: Friday, June 21, 2024</u>
<b>Milestone</b>	The <a href="#">C2C website</a> will be updated with forms received. <u>Deadline: Monday, June 24, 2024</u>

<b>Responsibility</b>	<p>Convene an ad hoc committee in a public meeting.  <u>Deadline: The proposed date is Friday, August 2, 2024</u></p>
<b>Responsibility</b>	<p>Draft report with recommended prioritization of the proposal forms submitted by Data and Tools Advisory Board members.  <u>Deadline: Monday, August 19, 2024</u></p> <ul style="list-style-type: none"> <li>• <i>The report will be drafted offline by members based off of the deliberation that takes place at the ad hoc committee meeting. Committee members will be responsible for the drafting of this report.</i></li> </ul>
<p><b>Fall</b></p>	
<b>Milestone</b>	<p>The pre-meeting survey will be shared with members, along with the ad hoc committee report and the report for a prioritization of the proposals submitted by members.  <u>Deadline: Monday, August 26, 2024</u></p>
<b>Responsibility</b>	<p>Members must complete the pre-meeting survey.</p> <ol style="list-style-type: none"> <li>1. Review submitted proposals from DTAB members, which may include sponsored ideas from the public;</li> <li>2. Review ad hoc committee report;</li> <li>3. Complete and score the proposals on pre-meeting survey, utilizing approved rubric.</li> </ol> <p><u>Deadline: Monday, September 9, 2024</u></p>
<b>Responsibility</b>	<p>Members must review the top three proposals. #1. Members will determine if the proposal needs amendments, and #2. If the proposal should be advanced to a feasibility study.  <u>Deadline: Tuesday October 1, 2024</u></p> <ul style="list-style-type: none"> <li>• <i>This will be an agenda item at the Data and Tools Advisory Board meeting on October 1, 2024.</i></li> </ul>
