Tamika Connor made a motion to approve Motions 1A, 1B, and 1C as follows; second Marshall Anthony Jr.

Motion 1A: Move to present the following metrics, which could be calculated from information already available in the P20W data set to the Governing Board at the May 1, 2024 Governing Board meeting and request that the Office create the following metrics: (1) Expansion of Postsecondary Retention Data Beyond a Single Year, (2) AP and IB Course Offerings, and (3) Early College Course Offerings (Dual Enrollment). And that the Office add the following disaggregation option to the College/Career Readiness Dashboard, which could be calculated from information already available in the P20W data set: (1) Whether students enrolled in postsecondary, based on the type of high school exit or by AP/IB coursetaking.

Motion 1B: Move to emphasize for the Governing Board the importance of the following data points that are already included in the P20W Data Set and planned data tools: (1) Career readiness: K-12 Individual Student College/Career Indicator Level, (2) AP course completion: Completed a K-12 Advanced Placement Course, (3) IB course completion: Completed a K-12 International Baccalaureate Course; (4) Dual enrollment: Completed a College Course While in High School, (5) Earned a special education diploma (Completed High School), (6) Cross-Institution Postsecondary Persistence Metrics, and (7) K-12 students who enrolled in postsecondary, with disaggregation

options based on early college credit, career and technical education coursetaking, and student demographics.

Motion 1C: Move to recommend that a-g Course Offering, Availability, and Completion data points be requested by the Governing Board to be added to the P20W data set by the California Department of Education, once the data meets CDE's data quality standards and the field is required for CALPADS reporting.

Diana Phuong made a motion to recommend that Retention by Student Major be requested by the Governing Board to be added as data points from the California State University and University of California by providing information of students' majors in each year of enrollment; second Brendan Livingston.
