At this meeting, the Governing Board (Board) will have the opportunity to approve the Data and Tools and Community Engagement Advisory Board candidates that were slated by the Selection for Advisory Boards Committee (Committee).

Requested Action:

After review and consideration of the slating of candidates for the Data and Tools and Community Engagement Advisory Boards, Staff recommends that the Board approve the slated candidates as presented by the Committee.

- Move to approve the proposed candidates and runners up for the Data and Tools Advisory Board as specified in the staff report.
- Move to approve the proposed candidates and runners up for the Community Engagement Advisory Board as specified in the staff report.

Background:

At the February 28, 2024 Board meeting, the Committee <u>charter</u> was approved, and five Board members were designated to form the Committee. Their role was to finalize selection and recruitment materials and to identify a candidate pool for approval by the Board. Member Payne, was Chair of this Committee and Governing Board members Gonzalez-Vasquez, Romero, Ohanian, and Vu also served on this Committee.

April 12, 2024 Committee Meeting:

As the Data and Tools Advisory Board and Community Engagement Advisory Board face vacancies, the Committee met on April 12 to approve and provide input on the application, rubric, and selection process plan. In addition, the Committee deliberated on the ideal populations for appointment and prioritization of future candidate categories for Advisory Boards. The 2024 Advisory Boards application forms were posted on the Cradle-to-Career Data's (C2C) website from April 29, 2024 through May 17, 2024.

June 27, 2024 Committee Meeting:

When the applications closed, the Committee reviewed and scored each application against the Committee approved rubric Multiple Committee members read and scored each application. The Committee convened on June 27 to discuss potential slates for each Advisory Board and rank-ordered runner up candidates. The approved ideal populations for appointment that were identified at the initial Committee meeting were taken into consideration during the slating process.

Data and Tools Advisory Board:

Education Code Section 10865 specifies that the Data and Tools Advisory Board holds responsibility for "examining whether the data system is providing actionable information and identifying ways to improve access to that information". The Data and Tools Advisory Board consists of 16 public members appointed by the Governing Board. More information about the current composition of the Data and Tools Advisory Board can be found in Attachment A.

In total, the Office of Cradle-to-Career Data (Office) received 28¹ <u>applications</u> for five impending Data and Tools Advisory Board vacancies. When the Committee prioritized candidates, they reviewed all applications; utilized the <u>scoring rubric</u>, which defines the criteria used for scoring the applications; and read <u>letters of support</u>. To facilitate the Committee's decision making, the Office organized the applications by category². There were three advocacy/community applications and 25 practitioner/researcher applications.

Data and Tools Recommended Slating:

During the June 27th meeting, the Committee met and approved five candidates shown below to the Data and Tools Advisory Board; however, on August 7, the Office received confirmation from a slated applicant that they are not a California resident. In the <u>Advisory Board application</u> under membership and terms it is noted that, "[a]dvisory Board members must be California residents" (pg. 8). As a result, one of the slated applicants, shown below, is not eligible to serve on the Data and Tools Advisory Board. In order to ensure that the five vacancies are filled, the first ranked runner up selected by the Committee was moved to a proposed candidate for appointment to the Data and Tools Advisory Board.

Data and Tools Recommended Runner Up Slating:

The Committee also approved the following candidates as runners up to the Data and Tools Advisory Board, in the order reflected below. As there were only five positions available for runners up, the <u>sixth place runner up</u> was not slated by the Committee on June 27th. However, with this shift in slating noted above, the first ranked runner up has been moved as a slated candidate for appointment to the Data and Tools Advisory Board, creating a vacancy in the runner up category. The sixth place runner up applicant has been moved to fill the vacancy.

Community Engagement Advisory Board:

Education Code Section 10865 specifies that the Community Engagement Advisory Board holds "responsibility for examining whether the managing entity is creating strong feedback loops with data users, supporting evidence-based decision-making and analytical capacity, and ensuring equitable access to actionable information". The Community Engagement Advisory Board consists of 16 public members appointed by the Governing Board. More information about the current composition of the Community Engagement Advisory Board can be found in Attachment B.

In total, the Office received 38³ <u>applications</u> for four impending Community Engagement Advisory Board vacancies. When the Committee prioritized candidates, they reviewed all applications; utilized the <u>scoring rubric</u>, which defines the criteria used for scoring the applications; and read the <u>letters of support</u>. To facilitate the Committee's decision making, the Office organized the applications by category⁴. There were six advocacy applications, six community applications, 22 practitioner applications, and four student applications.

Members Terming Out in 2024: Marshall Anthony Jr. (Advocacy Organization)



Dr. Marshall Anthony Jr. is the Director of Policy and Impact at Chegg, Inc., where he manages Chegg's Center for Digital Learning as well as the company's social impact arm, Chegg.org. For nearly 15 years, Marshall's personal and professional mission has aimed to maximize the educational and socioeconomic mobility of historically marginalized communities. He has published for various public, policy, and academic audiences. 
Karina Lopez (Practitioner)
