CCGI manages CaliforniaColleges.edu, the State of California's official college and career planning platform for 6th-12th grade students enrolled in public schools. CaliforniaColleges.edu can be used to close equity gaps by:

- 1. Systematizing college and career knowledge development for 6th-12th grade students.
- 2. Streamlining the college and financial aid application process for students and the educators supporting them.
- **3.** Providing educators with the data they need to:
 - Maximize course placement during high school.
 - Inform high stakes decisions about admissions, placement, advising, financial aid, and supportive services as students transition to college.



Partner Progression Graph






Basic Account Expansion: CDE

California's public school students in 6th-12th grade not otherwise served through Partner Accounts now have access to Basic Accounts based on CALPADS data.

- These accounts are available as of Fall 2024.
- Students, educators, and other users who have Basic Accounts are able to use many of the tools which do not require transcript data on CaliforniaColleges.edu.
- CDE has developed the <u>CCGI Flash</u> communication series to provide information on partnership with CCGI and expanded Basic Account access to LEAs.

Signed on June 29, 2024





SB 153: Summary of Changes

California State Education Code was updated in Summer 2024 with the following:



All districts serving 9th-12th grade students must **provide "transcript-informed" accounts** to their students; requires LEAs to enter data-sharing agreement with CCGI by January 1, 2026.



To support LEAs, requires **School Information System (SIS) vendors to comply** with the **California High School Transcript and Student Record Portability Standard ("Standard") and its associated Data Specification ("Spec")** and build an API, without passing any associated costs onto LEAs.



Using reports and technical assistance from CCGI, districts must maintain 90% alignment of A-G coursework with the Course Management Portal (CMP) .



California School Information Services (CSIS) will **notate SIS providers' compliance with the transcript Standard and Spec** and the format in which they can pass data to CCGI.

California High School Transcript and Student Record Portability Standard

Cal. Ed. Code § 60900.5 requires CCGI to provide:

(8)Transcripts processed in near real time with the California Community Colleges, the California State University, the University of California, and the Student Aid Commission, using an application programming interface.

To facilitate the work, CCGI developed the **California High School Transcript and Student Record Portability Standard** and its associated **Data Specification**.



California High School Transcript and Student Record Portability Standard

Why develop a standard?

- Reduces administrative burden for students navigating systems.
- Creates uniform guidance for how transcript data should be managed and shared electronically.
- Facilitates alignment across educational systems and the SIS providers serving them.

Updates on Implementation: Work with Student Information System Vendors





Leveraging the Capacity of SIS Vendors

- California Education Code Section 49083.5 requires SIS vendors to incorporate the data elements included in the the Standard and Spec and share that data to CCGI without passing any associated costs onto the LEAs.
 - Each SIS vendor is required to host an API to transmit the elements in the Spec to CCGI.
- California School Information Services (CSIS) will publish SIS vendors' compliance.








What is A-G Misalignment?

A-G mismatch occurs when the way an A-G subject area course is listed in a district's Student Information System (SIS) doesn't align with the way it is in the Course Management Portal (CMP).

Impact of CMP-Misaligned Courses

CaliforniaColleges.edu provides real-time data that helps inform educators' decisions about student coursework, guidance, and support.

This helps ensure that more students are able to successfully transition from high school to higher education.

Alignment with the CMP helps minimize:



Workloads of educators and counselors during application season



Number of students who do not get credit for courses completed



Time required for students to complete their Cal State Apply and UC Application(s)



Number of qualified students whose admission is delayed or denied due to data errors beyond their control



A-G Alignment Support

CCGI provides technical assistance help LEAs ensure that courses indicated as fulfilling A-G requirements match the CMP.

- California Education Code 60900(g) now requires that LEAs maintain at least a 90% rate of alignment between A-G coursework, as listed in the local SIS, and how those courses are registered in the UC Course Management Portal A-G course list.
- CCGI is offering course clean up events at the county level with 134 LEAs across 33 counties participating so far in 2024.
 - CCGI has a dedicated Technical Assistance team to support districts in improving their CMP match rate.
 - CaliforniaColleges.edu reporting features help educators identify and resolve issues with their CMP list that may impact eligibility for students.
