Section One: Succession Planning

#### Section Three:

Representation of Advisory Board Members

- Option B
  - Updated redlined language: Data and Tools Advisory Board members are appointed as individuals based on their experiences, expertise, and perspectives. An Advisory Board member or applicant shall not be employed by an entity with representation on the Governing Board, as outlined in the selection criteria detailed on page 24.
- Request the Office to look at the words entity, organization, institution in detail and align language to use just one in the redlined manual.

Additional Changes: Technical Additions, Clarifications, or Corrections Update to the Advisory Board Selection Criteria (Correction Number 7):

- Option B
  - Updated redlined language: If a seated Advisory Board member accepts employment with an organization already represented on the Governing Board, the member shall promptly notify the Office of their change in employment and resulting ineligibility to continue

their term. Upon such notification, the Advisory Board member will be deemed ineligible to complete the remainder of their three-year term. However, the member may continue to serve in their Advisory Board capacity until the Governing Board conducts its annual approval of Advisory Board appointments.
